#### PHILIP A. DAVIDSON

Once again we assemble to pay a memorial tribute to one of our colleagues. Philip A. Davidson departed this life on December 19, 1978, died young and prematurely, and left his family and friends at this season of joy and love. There is no joy in his passing, but there is love and respect in the hearts of those who will not forget him.

Phil Davidson was born on December 13, 1929 in Gary, Indiana. He took his elementary and high school education at Horace Mann School in Gary — a Bachelor of Arts Degree at Wabash College in 1951, and was graduated from Harvard Law School in 1954. He served in the Army of the United States from 1954 to 1956, and then embarked upon the practice of the law here in 1957 as an associate with the then Campbell, Livingston, Dildine and Haynie Law Firm. Following this affiliation, he served as corporate counsel for the Medical Protective Company for many years. More recently, he engaged in the general practice as a sole practitioner.

Mr. Davidson and his lovely wife, Frances, had three fine children. His mother and a brother also survive. He was a devoted family man, always dedicated with great affection to their best interests, and was attentive to his church and the well-being of the community.

For years, Phil suffered from a painful and sometimes debilitating disease of the bone. He suffered in silence and with courage. A friend said, "He didn't have a deceitful or dishonest bone in his body, and if Providence had offered to ease his pain by the substitute of such, Phil would have declined."

He was a gentle and warm person, and like so many sensitive people, expected his colleagues and others to be the same. Many of us, in our advocacy, so energetic and aggressive, would do well not to forget his kindness and patience.
