MEMORIAL RESOLUTION OF THE ALLEN COUNTY BAR ASSOCIATION

LEIGH L. HUNT

Mr. President, members of the Allen County Bar Association and friends:

"No more for him life's stormy conflicts, nor victory, nor defeat. No more time's dark events charging like ceaseless clouds across the sky."

We meet solemnly today to pay tribute to the life of a great advocate who has left this scene after playing a leading part for many years. Leigh Hunt died February 24, 1975. He had been an active participant in the legal affairs of this community for more than fifty years, having graduated from Indiana University in 1922. His legal career was spent on the local scene.

It is hardly necessary to comment to any extent on his career in the practice of law, for that record is inscribed in the decisions of the courts, both state and federal, as well as in the order books of the trial courts. As Leigh Hunt once said, "I hate estate work," so his practice developed accordingly. Very few lawyers have spent more time in litigation and in the courtroom than Leigh Hunt. Resourceful, innovative and thorough, few lawyers who worked either with or against him failed to learn

from him. He was a tireless worker who exhausted every avenue, if necessary, in behalf of his clients. He never gave up.

There are other aspects of his life which are less well known to the public. This is so because Leigh Hunt, to a large extent, lived a quite, private life never seeking the limelight. He served his country in the Army in time of trouble during World War I. After service, he returned to Whitley County, the county of his birth, where he served as a teacher and a school superintendent. All of these activities occurred before his long career in law. Leigh Hunt was a fisherman, a Bass fisherman, and had his own Shangrila at one of Canada's beautiful lakes. Rumor has it that he was quite adept at this avocation.

As might be expected of one so dedicated to the law, he was active in the professional associations dealing with the law. He held membership in this Association, Indiana State Bar Association, the American Bar Association, and the Bar Association of the Seventh Federal Circuit. Needless to say, he was active in these organizations, and in the past served as President of this Association and of the State Bar Association.

As he leaves this mortal scene a void will occur which will never be filled. He will be missed by those who have had occasion to do business with him. To his widow and his two daughters who remain, we express our profound sympathy at their loss.

BE IT NOW RESOLVED that the Allen County Bar Association give public expression of the sorrow of those members upon the death of Leigh L. Hunt.

BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to his widow Ruth Von Natta Hunt.

BE IT FURTHER RESOLVED that a copy of this Resolution be spread of record in the permanent records of the Courts of Allen County to evidence the respect and affection of the members of the Association for its departed brother.
