On February 28, 1960, at 10:00 o'clock in the morning the Creator saw fit to take from our midst a beloved and respected citizen of this community and a member of the Allen County Bar, Judge Dan C. Flanagan.

Dan was born on April 23, 1899 at Lafayette, Indiana, where his father Dan Patrick Flanagan practiced law, and it was inevitable that Dan should follow in his footsteps. He graduated from high school in Frankfort, Indiana and later enlisted in the Armed Services where he served with distinction as a Sergeant in the Field Artillery of World War I. After his separation from the Services, he enrolled in the Benjamin Harrison Law School, which is now known as the Indiana University School of Law, and graduated from this school with honors.

Immediately upon his graduation from law school he hung his shingle in Frankfort, Indiana, and practiced law there until 1924 when he moved to Fort Wayne.

Upon moving to Fort Wayne, he first became associated with the law firm of Heaton & Heaton. In the year 1931 he became a member of the firm of Leonard, Rose, Flanagan and McCreevy.

In 1925, shortly after coming to Fort Wayne, he became acquainted with Mabelle Cass, and Dan and Mabelle were married on October 5, 1925; and to this union one son, Daniel C. Flanagan, Jr., was born.

In 1934 the firm of Flanagan and Murphy was established and

Dan was associated with Jim Murphy until 1937 when he became associated

with Charles Bond in the firm then known as Flanagan and Bond.

Probably few members of this Association shall ever enjoy such a varied and interesting career, such as was Dan's good fortune to enjoy. He not only held the top political offices of his party in this county but also the highest office of his profession in this state. He served as Deputy Prosecutor in Clinton County in 1921 and 1922 and as Deputy Prosecutor in Allen County in 1929 and 1930. In 1936 Dan became Chairman of the Allen County Republican Central Committee and it was immediately after his assumption of the chairmanship of that committee that the fortunes of the Republican Party changed for the better, and during Dan's term as County Chairman many successful campaigns were conducted.

January 1, 1940 Dan was named Allen County Attorney and served in this capacity for approximately one year, at which time he was appointed to the Appellate Court by the Governor of the State of Indiana, for which office he later was a candidate, being the only candidate in history to win a State Convention nomination by acclamation four consecutive times. He won the office in 1940 and '44 and served in this capacity until 1948, at which time he returned to the general practice of law until again called to public service by the Governor when a vacancy occurred on the Supreme Court bench. Dan was appointed as a member of the Supreme Court of the State of Indiana in 1953 and served in that capacity until January of 1955. During this time as a member of the Appellate and Supreme Court Judge Flanagan handed down many profound and sound opinions, which are still being followed by the upper courts.

Dan returned to the practice of law again in Fort Wayne and in May of 1959 formed a new law firm with Robert S. McCain, which law firm was in existence at the time of Dan's death.

Dan, during his lifetime, was the recipient of many honors, having been named at one time to the Valparaiso University Law College extension lecture staff and also served on the permanent lecture staff of the University of Notre Dame. Of course everyone in the legal profession is acquainted with the fact that Dan was the author of several textbooks which have gained wide reputation and use throughout the profession, and, as a matter of fact, have been cited numerous times by the upper courts in their decisions.

In addition to the heavy load that Dan carried as a lawyer, judge, and author of legal textbooks, he always found time to be active in the Allen County Bar Association, Indiana State Bar Association, and American Bar Association, of which he was a member; and was always a willing and eager worker in civic and religious endeavor, being a member of St. Patrick's Church, Holy Name Society, Fourth Degree Enights of Columbus, and President of the Ancient Order of Hibernians.

During his lifetime he was never too busy to help and assist a young lawyer, and was always available to give advice or assistance whenever he could. During the latter part of his practice Dan often served in a consulting capacity for other lawyers and his keen insight into the law and his ability to immediately grasp the problems involved in any type of a lawsuit made him a most worthy opponent. It was not only a joy to work with Dan, it was also a pleasure to try a lawsuit against

him because from the beginning it was always a battle of wits. When Dan appeared in court, the Court was always well pleased to see him representing a client inasmuch as he knew that his client would have skilled representation, and that the legal points involved would remain clear-cut.

It is by no means intended that these few brief remarks should be a complete summation of Dan's Illustrious career and life. The presentation of merely the highlights alone would consume hours of time. If ever there existed a person who understood the value, use, meaning and purpose of life, it was Dan Flanagan.

Dan was a considerate husband and devoted father, and his passing was untimely. All of us know that Dan did not regard his life's work as complete. Had he lived, the balance of his life would have been devoted to service of his fellow man. We all feel a great sense of personal loss at his passing. We shall miss him.

Therefore, Be It Resolved that the Allen County Indiana Bar Association give a public expression of the sorrow of its members on the death of Judge Dan C. Flanagan.
