In his early life he joined the Democratic party and was very active in politics and political circles not only in Allen County but in the State of Indiana. He was known from one end of the State to the other. He maintained his interest in politics up to the date of his death. In his earlier years he was the local leader of the party and as a reward for his many efforts and his time and devotion to the cause, he was given the position of City Attorney for Fort Wayne, which he maintained for a number of years.

It has been thoroughly established by mankind as it has been taught to us by all religions that it is better to give than to receive and that this qualify actually makes up the worthiness of our lives.

That sentiment was never more emphatically illustrated than by the life and activities of our deceased member, Guy E. Colerick.

His experience, his work, his association, not only in his business but in his social and political life can best be summed up by the statement that no matter where he found himself or what task was given him to perform, he efficiently discharged his duty and brought honor not only to himself but to his profession.

In his private life he was a pleasant and agreeable companion and a steadfast friend. He had a wonderful capacity to hold the friend-ships which he had made and his friends were numbered only by his ability to make contacts.

The community has profited by his life and his personal, business, social and civic values.
