The Allen County Indiana Bar Association meets once again to pay its respect to the memory of one of its members.

Charles E. Dare died on Tuesday, May 23, 1972, at his home, 4527 Lafayette Esplanade. He was 80 years of age.

He is survived by his widow, Amelia; a son, Lowell A. of Franklin, Indiana; a daughter, Virginia C. Dare, Detroit, Michigan; and five grandchildren.

A native of Lagro, he received his Law Degree from Indiana Univeristy School of Law and served in the Army in World War I.

Mr. Dare served as an Indiana Deputy Secretary of State under Secretaries of State Frederick E. Shortemeier and Otto G. Fifield from 1926 to 1930. He also was Assistant Secretary of State during the administration of Governor Harry Leslie.

Mr. Dare served on the Indiana Corporation Survey Commission for a number of years and also served as Juvenile Attorney under the late Judge William H. Schannen of the Allen County Circuit Court for 18 years.

Other positions of public service in which he served were as Fort Wayne Director of Civil Defense in World War II and also as a former Allen County Deputy Prosecutor.

Mr. Dare was an instructor at International Business College for a number of years.

He was a member of the Mother Church of the Church of Christ, Scientist, Boston, and also attended the First Christian Church.



In his profession, Mr. Dare continually sought the attainment of perfection in his practice and would devote many hours to be sure that everything he did was correct and in the best interests of his clients. He also had and took the time to consult with younger members of the profession whenever they sought his advice in areas of his particular expertise. Mr. Dare enjoyed a wide acquaintance and was held in high respect by the members of his profession and the community at large for his many contributions as a dedicated, public-spirited citizen.

To his family and to his many friends, the Allen County Bar Association pauses to extend its sympathy.
