EDWARD W. YOUNG

Edward W. Young died in the Lutheran Hospital at 4:15 A.M., Sunday, July 5, 1970.

Ed was a true and fine gentleman in all the inclusive meanings of those words. He gave of himself to family, friends, fraternal organizations, clients and the bank for which he loyally served, and to the entire community in selfless, generous manner. All who associated with Ed placed unlimited confidence in him and were proud to be listed among his friends.

Edward W. Young was born in the City of Fort Wayne, Indiana, and attended the Lutheran schools of this City, LaSalle College and graduated from International Business College. He was admitted to the practice of law in the State of Indiana in the year 1919.

After graduation from college, he served as clerk in the office of the Clerk of Allen County, Indiana, where he attracted the attention of Guy Colerick, a lawyer of outstanding abilities. Ed's association with Guy Colerick continued for a number of years until he became an employee of the Lincoln National Bank and Trust Company of Fort Wayne in the year 1927. Because of Ed's ability as a lawyer he participated in organizing the Trust Department of that bank and in the year 1944 was elected Vice-President and Trust Officer and continued that association until the year 1964.

Ed was a member of Trinity English Lutheran Church and served on the church counsel for many years. He was a member of the Board of Managers of Irene Byron Hospital since 1953 and was a 50 year member of the Allen County Indiana Bar Association. He was a veteran of World War I and a member of American Legion Post 47. Ed was also

a member of Maumee Lodge No. 725 F. & A. M., Mizpah Temple A.A.O.N.M.S., Royal Order of Jesters Court No. 27 and several years ago served as Director. He was also a member of the Fort Wayne Chapter No. 19 Royal Arch Masons, Fort Wayne Counsel No. 4 and Fort Wayne Commandery Knights Templar of the York Rite, Chamber of Commerce and was a member and past Treasurer of the Fort Wayne Rotary Club.

His generous contributions to his Church, to his family and friends, to his community and to his Country have been many and varied.

His loyalty to friends and his love of friendship, his geniality and humility have greatly added to the betterment of human affairs.

Edward W. Young was survived by his wife, Victoria G. Young, his daughter, Marilyn Finkbeiner, his son, Donald G. Young, and five grandchildren.

The death of Edward W. Young is our loss. We cherish his memory.
