MEMORIAL RESOLUTION OF THE ALLEN COUNTY BAR ASSOCIATION

Kenneth M. Waterman

WHEREAS, we are here to pay our respects to the memory of our deceased colleague and friend, Kenneth M. Waterman, who passed away on January 23, 2012, at the age of 73.

WHEREAS, Ken, was born in Linton, Indiana to J. Wayne and Edith Waterman on November 24, 1938. Due to his father's position as a civil engineer for the federal government and the resulting job transfers, Ken grew up in Indianapolis, Indiana and Grand Rapids, Michigan. He graduated from high school in Grand Rapids in 1957 and attended the University of Michigan, Ann Arbor, Michigan graduating in 1961 with a Bachelor of Arts Degree. Ken went on to attend the Indiana University School of Law (Bloomington) receiving his Juris Doctor in 1964.

WHEREAS, after graduating from law school, he was admitted to practice law in the State of Indiana in 1964. Ken served as a Deputy Attorney General for the State of Indiana in 1965-66. Ken came to Allen County in 1966 and began practicing law in the law firm of Korn, Wyss, McCain, Mochamer & Waterman. He also practiced with the law firms of Parker, Hoover & Rush, Shoaff, Parker & Keegan, and Baker & Daniels. In 1994, Ken became semiretired and practiced as a solo practitioner. He was a member of the Allen County Bar Association, the Indiana Bar Association and the American Bar Association. In addition to being admitted to practice law in Indiana, Ken was admitted to practice law before the United States District Court for the Northern and Southern Districts of Indiana, the United States Tax Court, the United States Court of Military Appeals, the Seventh Circuit Court of Appeals and the United States Supreme Court. Ken was well respected by his colleagues in the bar, by the members of the bench in the state and federal courts and by the numerous clients who Ken represented during his long and honorable career.

WHEREAS, Ken served 20 years in the U.S. Naval Reserve as a member of the Judge Advocate General's Corp. He retired with the rank of Commander.

WHEREAS, in addition to his professional life, Ken was involved in the community. He was a member of the Mizpah Shrine and served as a past Master of the Maumee Lodge, 33^{rd} Degree, Scottish Rite, Mizpah Shrine, York Rite, and the Royal Order of the Jesters. He was active with the Boy Scouts and served as an attorney for the Anthony Wayne Area Council-Boy Scouts of America.

WHEREAS, Ken was a loving husband, and a kind and proud father and grandfather. He met his wife. Kay (Johnston) while Ken was attending law school in Bloomington. They were married on August 14, 1965. They lived in Indianapolis and moved to Fort Wayne in 1966. They are the parents of two sons, Jeffrey M. Waterman (married to Yvette) who live in Indianapolis, Indiana, and John R. Waterman (married to Alyssa Doolittle) who live in East Burke, Vermont; Ken is survived by five grandchildren, Cecelia, Patrick, Peter, Elizabeth and Luna May. Ken loved his time with his family, especially in the summers when he, Kay and the boys would spend time at their lake cottage. Ken enjoyed genealogy and wrote a book on the Waterman family that can be found in the Allen County Public Library.

WHEREAS, Kenneth M. Waterman was regarded as scholarly, intelligent, articulate, kind, compassionate, humorous, interesting, generous and honest.

NOW, THEREFORE, BE IT RESOLVED that the Allen County Bar Association gives public expression of sorrow upon this, the occasion of the remembrance of the life of Ken M. Waterman.
