Once again, the members of the Allen County Bar Association meet to pay tribute to one of its younger members, Richard W. George died on April 13, 1973 after a short illess.

"Dick", as he was known to our members, was a native of Indianapolis and came to Fort Wayne approximately ten years ago. We regret that his legal career was abbreviated by his unexpected passing, but his family can be proud of his many accomplishments. Dick was a Marion County Deputy Prosecutor in the late 1950's, and subsequently was a member of the Indiana Attorney General's staff in the early 1960's and the members of our Bar became acquainted with him when he participated in several suits to condemn land for Interstate 69 in the Fort Wayne area. Thereafter he became associated with J. Robert Arnold in the law firm of Arnold and George, and also served as an Associate City Attorney. Subsequently he became a member of the law firm of Bloom and Bloom; and for the last several months had his own firm.

Dick George was a member of the United Methodist Church, the Phi Delta Phi legal fraternity, and the Fort Wayne Press Club.

As we meet here today to commemorate the life and accomplishments of our departed member, Richard W. George, there is much to be learned for our exemplification by a

review of his career and achievements. He was well respected as a member of the Attorney General's staff and was never too busy that he wouldn't take time to aid a brother lawyer in making his task easier. He gained for himself the respect of his clients and brother lawyers. His passing was untimely.

Dick is survived by his wife, Carolyn; three sons, Keith at home; Steve at Wright-Patterson Air Force Base, Dayton, Ohio; and Henry at St. Petersburg, Florida; his parents, Mr. and Mrs. John George of Indianapolis, and one brother, Philip of Madison.

The Allen County Bar Association will miss Dick George.
