MEMORIAL RESOLUTION OF THE
ALLEN COUNTY BAR ASSOCIATION

DAVID HOGG

Mr. President, members of the Allen County Bar Association, my friends all:

This morning the Allen County Bar Association assembles to pay tribute to one of its most distinguished members, David Hogg, who died on October 23, 1973, after a long and honorable career as a member of this Bar and in service to our community.

David Hogg is a gentlemen that we shall long remember for his friendliness, his graciousness, and his pleasant personality.

We are fortunate to have enjoyed his friendship and companionship for a great many years. David Hogg became a member of the Allen County Bar Association approximately sixty years ago, having graduated from the Indiana University Law School in 1913.

David Hogg was born on the 21st day of August, 1887, a native of Crothersville. One year after his graduation from high school Mr. Hogg worked for the United States Post Office in Crothersville. Later he obtained a license to teach school and became the youngest teacher in the township, and subsequently became the Principal of the township school.

Mr. Hogg was elected to the House of Representatives from the 4th Congressional District in the year 1924, assuming the oath of this office on March 4, 1925, and serving in that capacity until December 31, 1932. He also served three years as Chairman of the Allen County Republican Central Committee,

resigning that position to enter the race for Congress. During this campaign Mr. Hogg made a house to house canvass of the voters in the 4th District, and primarily because of the result of his efforts he was successful in this election.

Upon the termination of his career in Congress he again took up the practice of law in Fort Wayne in association with the late Judge George H. Leonard; thereafter he was associated with David Peters; and his most recent association was with the law firm of Hogg, Snouffer, Haller and Colvin.

David Hogg was a member and former elder and trustee of the First Christian Church and devoted a great deal of his time to the practice and teachings of the church. He was President of Goodwill Industries at one time and also the first President of the Associated Churches of Fort Wayne.

David Hogg was one of the founders and later became general counsel and member of the Board of Directors of the Mutual Security Life Insurance Company. He was a member of the Allen County Bar Association and the Indiana State Bar Association. He was admitted to practice before the United States Supreme Court. Along with his local community efforts he was a member of the Masonic Lodge, Scottish Rite, the York Rite, Club Olympia, YMCA and the Chamber of Commerce.

David Hogg was a dedicated lawyer and a devoted husband. The members of the Allen County Bar Association extend their deepest sympathy to his wife. We are proud to remember him as an outstanding citizen in our community and for his many accomplishments during his life.


BE IT RESOLVED that the Allen County Bar Association give public expression of sorrow of its members upon the death of David Hogg; and
