GEORGE KOWALCZYK

We are here to pay respects to the memory of our deceased colleague and friend, George Kowalczyk, who passed away peacefully at his home on August 5, 2005.

Born in Fort Wayne on February 22, 1911, George was the second oldest son of Waclaw and Stefania Kowalczyk, who immigrated from Poland in 1905. George attended Nebraska Elementary School, Franklin Middle School and North Side High School. He attended the University of Wisconsin and received his undergraduate degree in 1934 and his law degree from the Wisconsin Law School in 1936. George was also a member of the legal fraternity, Phi Delta Phi.

George Kowalczyk was admitted to the practice of law in the State of Indiana and the State of Wisconsin in 1936. George loved the law. When he was fourteen years old, he met attorney John Morris while caddying at the Fort Wayne Country Club, and he hung around the Morris and Newkirk law offices throughout high school, running errands and driving Mr. Morris in his declining years. He was last a partner of the Fort Wayne law firm Newkirk, Keane, Kowalczyk & Leal. His career as a probate and real estate lawyer spanned seven (7) decades until his retirement in 1998. At the time of his death, George was of counsel with Schenkel, Tirpak & Kowalczyk.

In 1941, George joined the Federal Bureau of Investigation and served as a counterespionage agent in Argentina, and as a special agent against organized crime in both Pittsburgh and Chicago. George was a Captain in the United States Marine Corps from 1944-45. He was engaged in the neutralization of the Marshall Islands and Okinawa Island in the Pacific Theatre, and as a temporary occupation officer at Nagasaki, Japan. After World War II, he served with the 9th Rifle Company in the U.S.M.C. Reserves in Fort Wayne.

George exemplified service and leadership to our community. He served two terms on the Board of Managers of the Indiana State Bar Association and was an Indiana Bar Fellow. From 1959 to 1964, he served on the Allen County School Reorganization Committee, part of the statewide effort to consolidate public school districts. In the 1950s and 1960's, he served on the Aboite Township School Advisory Committee, and was instrumental in the Township's purchase of the acreage that now houses Homestead High School, Woodside Middle School,

and the Township Hall, Fire Station and Trustee's Office. From 1976 to 1985, George served as the Attorney for the Board of Trustees of the Allen County War Memorial Coliseum. This was a particular source of pride for him, as he had been on the Allen County Council of Veterans, and was the Master of Ceremonies when the Coliseum was first dedicated in 1952. In the 1980's, he served on the Board of the Peoples Trust Bank, now a part of JPMorgan Chase Bank, NA.

George was also a member of the American Legion Post 47 and Disabled American Veterans Post 40. He was a past commander of Veterans of Foreign Wars Post 9500. He was a member of the Caldron Club, the SERRA Club, the Sol D. Bayless Masonic Lodge #359, the Mizpah Temple and the Scottish Rite. He was a member of the St. John the Baptist parish in Fort Wayne.

George's first wife, Marion Stuart, preceded him in death. George is survived by his wife, Agnes and his son, John of Fort Wayne and daughter, Mary A. Lindenmeyer of Batesville, Indiana, four grandchildren, two great-grandchildren and his brother, Victor, of Marietta, Georgia. George was also preceded in death by his brothers, Harry, Bronson and Henry.

George Kowalczyk will be remembered by his family, friends and colleagues as not only an outstanding lawyer but as a true and loyal friend, a proud man who was very courteous to his colleagues, a man of his word and who was very exact in his work. George was well known and regarded for his accuracy in his real estate abstract opinions.
