

**MEMORIAL RESOLUTION OF THE
ALLEN COUNTY BAR ASSOCIATION**

SCOTT T. NIEMANN

WHEREAS *we have gathered here today to pay our respects to the memory of our deceased colleague and friend, Scott T. Niemann, who passed away on March 30, 2004; and*

WHEREAS *Scott Niemann was born July 16, 1951 in Crookston, Minnesota and grew up in Ulen, Minnesota and Hillsboro, Illinois. He received his Bachelor of Arts degree from McMurray College in 1969 and his Doctor of Jurisprudence degree from Indiana University, Bloomington, Indiana in 1980 where he was also elected a member of the Order of the Coif; and*

WHEREAS *Scott Niemann was widely respected as an attorney in this community. Scott was admitted to practice law in the State of Indiana, and in the Federal Courts for the Northern and Southern Districts of Indiana in 1980. He was a member of the Allen County Bar Association since 1980 and was also a member of the American Bar Association, the Indiana State Bar Association, and the American Inns of Court. Scott began his legal career in Fort Wayne with the firm of Rothberg, Gallmeyer, Fruechtenicht & Logan, where he remained until 1999. Scott then became a partner in Burt, Blee, Dixon and Sutton where he practiced until 2002. In 2002, along with his good friend Martin Fletcher, he founded the firm of Fletcher & Niemann. Scott was a litigator and often practiced before the Allen Circuit and Superior Courts, as well as the United States District Court sitting in Fort Wayne.*

WHEREAS *Scott Niemann was also an active member of this community. He was deeply involved in the Canterbury School, where his children attended. Scott served on the finance committee for the school and served on the Board of Trustees from 1988 to 1992.*

WHEREAS *Scott Niemann is survived by his wife Bonnie, by his daughters Michelle and Carol, and by his son David; and*

WHEREAS *Scott Niemann will be remembered by his friends, colleagues and the residents of Allen County not only as an outstanding attorney, but also as a civic leader, a colleague, and as a good friend.*


NOW THEREFORE IT IS HEREBY RESOLVED by the Allen County Bar Association duly assembled this 4th day of June, 2004, in a courtroom of the Allen County Courthouse, that the profound respect which the association has for Scott T. Niemann, in appreciation for his long and distinguished career as an attorney and community leader be duly recorded in this manner and that condolences be extended to his family.


